**NOTICE OF EXTENSION OF WRITTEN COMMENT PERIOD**

Notice is hereby given that the Department of Transportation (Caltrans) has extended the written comment period originally scheduled to end at 5:00 p.m. on August 14, 2015 regarding the modified proposed text of the Affordable Sales Regulations proposed to implement, interpret, and make specific Section 54237 through 54238.7 of the Government code and the revised Standardized Regulatory Impact Assessment (SRIA), pursuant to the Notice of Revised Standardized Regulatory Impact Assessment and Modifications to Text of Proposed Regulations for Affordable Sales Program filed with the Office of Administrative Law and originally published on July 1, 2015 to allow all interested parties more time to comment. The text of the modified proposed regulation has not been modified in any way since its July 1, 2015 filing with the Office of Administrative Law.

Written comments pertaining to the modifications to the text of the proposed regulation or the revised SRIA, including those sent by mail, facsimile, or e-mail to the address listed under the Written Comment Period in this Notice, must be received by Caltrans no later than 5:00 p.m. on August 24, 2015.
