CITY OF SOUTH PASADENA CULTURAL HERITAGE COMMISSION PUBLIC HEARING NOTICE

NOTICE IS HEREBY GIVEN that the City of South Pasadena Cultural Heritage Commission will hold a public hearing on **September 21, 2023, at 6:30 p.m.** through an in-person meeting to consider the following projects:

PROJECT NO. 2513-COA – A request for a Certificate of Appropriateness for a 175 square-foot first story expansion and a 484 square-foot second story addition to an existing 1,303 square-foot, one-story single-family residence located at 541 Prospect Avenue (APN: 5317-036-031). In accordance with the California Environmental Quality Act (CEQA), the project qualifies for a Categorical Exemption under Section 15301, Class 1 (Existing Facilities) and Section 15331, Class 31 (Historical Resource Restoration/Rehabilitation).

PROJECT NO. 2562-NID-DRX – A request for a Notice of Intent to demolish a 655-square-foot single-family residence located at 827 El Centro Street (APN: 5315-019-027). Projects submitted to the Planning Division that include the demolition of buildings constructed at least 45 years prior to date of the application are required to be evaluated by the Cultural Heritage Commission to determine if the property could potentially meet national, state, or local criteria for historic designation. In accordance with the California Environmental Quality Act (CEQA), the project qualifies for the Categorical Exemption under Section 15061(b)(3) – Common Sense Exemption and Class 3, Section 15303 (New Construction or Conversion of Small Structures).
