# 1. Review and approve draft minutes of the regular meeting held December 12, 2019

### 3. Introduction of New Trustee Annie Chang

Trustee Annie Chang introduced herself to the Board of Trustees. Annie has a Master's degree in Public Policy from USC and a Bachelor's degree in Political Science from UCLA. Annie is currently the Associate Director for the Nonprofit Finance Fund Advisory Services. Annie has worked as the Senior Program Officer for First 5 Los Angeles, as a Senior Consultant with Deloitte Consulting Human Capital Practice, as a municipal bond campaign consultant, and as a legislative consultant and fellow with the California State Assembly. Annie has 3 young children who are enrolled or will be enrolled in SPUSD.

# 4. One City One Story

Public Services Manager Maida Wong presented the selection and implementation process for the One City, One Story project. One option would be to survey the community for suggestions and to select a committee to choose the finalist. Another option would be for library leadership to assemble a committee to nominate a book to be presented to the community. A third possibility would be for library staff to select a book without any input from the community. The library staff recommends a committee selecting a short list of titles that could be presented to the community.

Once the book has been chosen, an event would be held to encourage participation and to inform the community about upcoming programming and activities related to the book. The size of the committee and who will serve on it will likely be determined in February. \$5K has been allotted for this project. The main event—likely a talk by the author—would be scheduled in September.

# 7. Library Staffing Update

Full Time Children's Librarian Judy Neeb and Adult Services/Digital Services Librarian Cynthia Mitchem will start on 1/21/20. Library Aide Interviews were completed on 12/1/19 and the background check has begun for the top 3 candidates. Applications for the Part Time Library Clerk position will be reviewed.

### 8. Eliminating Library Overdue Fines

Many libraries, including the Los Angeles Public Library, are moving away from collecting fines for overdue materials. The revenue generated from South Pasadena Library fines has been declining each year. Research has shown that overdue fines are punitive and disproportionally impact people facing socio-economic challenges.

### 13. <u>Library Director (Cathy Billings):</u>

- Police Walkthroughs have been more consistent.
- Public Services Manager Maida Wong and Director Billings are pursuing a partnership with Videotheque and a local resident who is a film scholar for a possible film series.
- Public Services Manager Maida Wong and Director Billings met with the Eclectic Music Festival committee. The Library will be one of the venues for the Eclectic Music Festival for possibly 3 musical acts to perform on the lawn outside the Community Room.
- The Arts Crawl will be on 2/15/20. The Chamber's Artisans' Alley will take place in the Community Room, along with a Chamber sponsored hands-on craft activity and performances by the LA Children's Orchestra.
- Local History Librarian Olivia Shea is developing a program with Baranger Studios about their storewindow mechanical animated advertising displays for jewelry stores.
- The new librarians will organize Author Talks for later in the year.
- As of 1/2/20 the Public Computer workstations now offer 2 daily 1 hour sessions (up from 3 half hour sessions) and require a pin and library card number to gain access, improving security and customer satisfaction.
- The request for auto-renewal has been submitted to SirsiDynix.
