Secretary Pearson was disappointed by the "Libraries of the Future" program at the Library Foundation of Los Angeles. It mainly spoke about current activities, with little said about the future of libraries. The director of the Pacific Palisades branch of the LA Public Library spoke about using similar methods adopted during the pandemic to maintain its services, after its building was lost during the Palisades Fires.
