# MINUTES REGULAR MEETING THURSDAY, MAY 8, 2025, AT 7:00 P.M.

President Long thanked Director Billings, Friends Board President Kevin O'Neill, and the Library Board for successfully organizing the Volunteer Appreciation Event. President Long's son will be a volunteer for the Summer Reading Program. She expressed appreciation to Children's Librarian Leticia Cheng Ku for running a smooth orientation process.

## 11. BOARD MEMBER COMMUNICATIONS

Trustee Serwin warned of the threat that libraries currently face. He would like the City Attorney to outline what the Library Board can do to sound the notice about attacks against the freedom of thought, expression, and speech.

Secretary Pearson shared a poster with a quote by Kurt Vonnegut regarding "the subject of burning books." He also shared some library trivia that the word "liber," which was the inner bark of a tree that was used as paper, was how the word "library" originated. He also thought it was very exciting that a local South Pasadenan High School violinist was mentioned on KUSC.

#### 12. COUNCIL LIAISON COMMUNICATIONS

City Council Liaison Primuth shared four updates from the last City Council meeting: the City approved the contract to receive two self-cleaning, public toilets on the plaza near the Metro station, at no cost, in the run-up to the Olympics and World Cup; slight modifications have been made to the tree-trimming ordinances to allow the Public Works Director to make the final determination on certain tree removals; a settlement agreement has been approved for a multi-unit development in the Altos, near Camino Del Cielo; several positions have been approved for the Public Works department to allow for a better delivery system for projects.

Council Liaison Primuth chaperoned a trip to China with 68 South Pasadena High School students. It was a wonderful opportunity to meet with Chinese students and teachers, to visit their schools, and experience their culture and encourage friendships that transcend political differences.
