**SUBJECT:** Slow Streets Program Update and Recommendation to City Council

#### Recommendation

It is recommended that the Mobility and Transportation Infrastructure Commission (MTIC):

- 1. Receive and file an update on the Slow Streets Program;
- 2. Advise on centerline removal methods; and
- 3. Recommend the City Council to approve the installation of the temporary program equipment along the residential streets.

#### **Background**

The City's Slow Streets Program is intended to provide space for residents to safely walk and ride, and to support local businesses' use of outdoor space for dining and other operation purposes. The program is accomplished by installing temporary traffic equipment along selected streets. In residential areas, the program includes the installation of temporary striping, signage, curb extensions using reflective delineators, and bicycle lanes using short-term paint/tape. In addition to the listed elements, the commercial areas include the use of temporary parklet structures, furniture, planters, and art pieces.

In 2021, Public Works staff completed the pre-design outreach and prepared preliminary engineering drawings illustrating the striping, curb extensions, parking and parklet layouts to properly install program equipment along Mission Street, Hermosa Street, Grand Avenue, and Oak Street. Subsequently, staff was able to utilize a \$420,000 LA Metro Cycle 3 Open Streets Grant to purchase most of these components.

As COVID health and safety restrictions are lifted, the purpose of the program shifts from pandemic relief to potential permanent reconfigurations of City streets. The long-term re-vision continues to support the City's intent to promote active transportation and economic development.

#### **Discussion/Analysis**

Attachment 1 illustrates the proposed layout of the residential improvements, which includes the implementation of bicycle lanes, curb extensions, crosswalks, signage and striping along Oak Street from Meridian Avenue to Garfield Avenue, Grand Avenue from Mission Street to Columbia Street, and Hermosa Street from Grand Avenue to Columbia Avenue. Subsequently, the Commission previously suggested the installation of a climbing lane on Hermosa Street and

chicanes along Hermosa Street between Grand Avenue to Floral Park Terrace. In order to incorporate these changes into the design, this would require the eradication or covering the existing center line and markings on a temporary or permanent basis and shifting the centerline to accommodate a climbing lane. Attachment 2 summarizes the methods and associated costs for the centerline removal on Hermosa Street. Since Hermosa Street is a residential (Local Street), staff recommends following up with the permanent removal approach for the centerline, which can help reduce traffic speed. In an effort to provide enough time for evaluation and reporting, the deadline for demonstration project installation is August 30, 2023.

On May 11, 2023, Public Works staff were invited to the Chamber of Commerce Economic Development Committee meeting to provide an update of the Slow Streets Program. At the meeting, staff primarily discussed the proposed improvements along the commercial district. Staff presented the scope and the timeline of the project, an example of the Mission Street design, purchased furniture and past and upcoming outreach events. The businesses were generally in support of the project.

Prior to implementing the Mission Street design, the project team will continue to hold outreach events, meeting with stakeholders, and sharing final drafts of the design for community's review and feedback. The final design will incorporate the community's comments, and will be presented to the City Council for approval. Furthermore, during the installation, the project team will gather feedback and input at City/corridor events, the South Pasadena Farmer's Market, or other on-site opportunities. After the demonstration phase is completed, the project team will develop an evaluation report, which will include an assessment of the design's observable performance, and an evaluation of the community's experience during and at the conclusion of the program.



#### Recommendation

Staff recommends that the Mobility and Transportation Infrastructure Commission (MTIC) consider and make recommendation regarding resident's concerns along Huntington Drive.

#### **Background**

On February 17, 2023, a motorist lost control of his vehicle and struck several parked cars along the south curb line prolongation of East Huntington Drive near the 2100 block of Huntington Drive. A week later, City Staff, Police Department, City Manager's office and Council Member Braun met with residents to discuss the collision from February 17, 2023, and safety related concerns. A few weeks later, the issue was presented at the March 13<sup>th</sup> South Pasadena Public Safety Commission (PSC) meeting where residents expressed the need for roadway redesign. The Police Department highlighted their safety efforts educational campaign with signage, the placement of decoy police vehicles, radar trailer deployment, and increased enforcement efforts.

On April 18, 2023, a listening session was conducted with Public Works, Police Department, Deputy City Manager, Mayor and Councilmember Braun where residents shared speeding incidents along Huntington Drive and proposed some solutions to mitigate speeding on weekend evenings from 7 pm to 11 pm. Some of the recommendations that were introduced by residents were bollard installation to protect properties, synchronization of traffic lights, flashing red signals overnight, traffic of pedestrian light at Court Street, and reflective markers or paint for parked vehicles.

#### Discussion/Analysis

In response to the community's concerns, the Public Works Department and South Pasadena Police Department have worked together and implemented some short-term actions to mitigate vehicular speeding along Huntington Drive. Police have increased patrols and have installed "Slow Down South Pasadena" lawn signage along Huntington Drive east, west and center median. Public Works staff temporarily deployed their larger portable changeable message sign (PCMS) to East Huntington Drive and Dos Robles Place to remind and emphasize to motorists of the speed limit and the radar enforcement the police department conducts along Huntington

Drive. The PCMS will supplement and augment existing regulatory and warning signs along this corridor.

On May 18, 2023, Public Works staff and the South Pasadena Police Department staff conducted a walkthrough with residents at Huntington Drive. Approximately 16 residents attended the meeting and shared some of their experiences, issues, and street improvement recommendations which included speed management, pedestrian infrastructure improvements, illegal vehicle movements, left and U-turn movements at certain intersections and other. Residents also offered some solutions such as enhanced pedestrian crossing at Huntington Drive and Court Ave, removing a bus stop, striping parking boxes along Huntington Drive, red light traffic cameras, synchronizing traffic lights, or flashing red signals overnight, and bollards. Resident's detailed comments and feedback are included as Attachments 1, 2, 3, and 4 for further reference.

The South Pasadena Police Department gathered data concerning collisions along 2000 block of Huntington Drive and showed that several collisions involved speeding or failure to yield as the primary collision factor as shown on Table 1.

The 10-year traffic collision history obtained from the Statewide Integrated Traffic Records (SWITRS) and UC Berkeley's Transportation Injury Mapping System (TIMS) was analyzed as well. SWITRS Collision data from 2012 to 2022 is included as Attachment 4. The data revealed that 742 collisions occurred in the City of South Pasadena in the last decade from December 31, 2012 to December 31, 2022. Out of the 742 collisions in the city, 83 occurred along Huntington Drive between Alhambra Road to Garfield Avenue, and 25 out of 83 involved unsafe speeding violation and 21 out of 83 involved traffic signal or sign violation.

While the Public Works continues receiving input from residents, staff has initiated discussions with a consultant to conceptualize an active transportation corridor and overall circulation improvements for pedestrian, buses, cyclists, and others to serve the community and all

transportation modes. Some of these elements and features will include bike lanes, safer crossings, high visibility crosswalks that include flashing beacons and modifications of median and refugee islands for safer crossings along Huntington Drive from Alhambra Road to Garfield Avenue (1.5 miles) and Fremont Avenue between Alhambra Road and Columbia Street (1.8 miles). Other pedestrian and bus amenities will be incorporated to meet the needs of all users of the corridor. As the project begins moving forward, all stakeholders in the community will be invited and have an opportunity to provide input and suggestions to help design multimodal streets that support and facilitate the mobility needs of all users for the future.


## **Accident History 2013 to 2023**


On February 17, 2023 at 8:37pm, Street Racer Daniel Martinez lost control of his 2007 Honda Civic at 80 MPH, spun out backwards, and hit two parked cars. One car breached the sidewalk and the other was pushed forward 4' into a driveway. All cars involved were totaled.

Approximately 2021, a 1966 vintage Thunderbird was totaled and breached the curb.


Approximately 2020, drunk driver in Mini Cooper missed the parked cars, breached the curb & sidewalk, and came to a stop within 4" of a residence at 2051.

Mr. David Keily and Mr. Laben Spicer have more crash history.





Please - we need your help to stop this reckless activity before we have a much bigger incident on our hands.




Mr. Hernandez's rate of speed was 80+ MPH... backwards!!

If there was a backseat passenger, this could have been a **fatal crash** – just so this 33-year old man could feel like he was playing Grand Theft Auto on Huntington Drive at 8:37pm on a Friday.

If the totaled Inifinti SUV and Toyota Solara were not parked where they were, at least one resident that night would have had Mr. Hernandez <u>and his car</u> inside their home.











## Meeting on February 24, 2023

<u>Attendees</u>: SPPD Chief Brian Solinsky, my councilperson Janet Braun, Deputy City Manager Domenica Megerdichian

<u>Purpose</u>: Demonstrate how close this accident was from hitting housing <u>and</u> how deadly it could have been for any pedestrian due to chunks of flying windshield for 60+ feet.

Mayor Primuth emailed me that he is following the situation and the "...commissions need to come up with safety improvements to protect our residents from this dangerous activity."\*

Result: This is a multi-level problem requiring multiple solutions.

# **Identifying the Problems**

- 1. Safety of Sidewalk Pedestrians & Bus Riders
- 2. Track Record of Danger to Residential Buildings
- 3. Speed
- 4. Significant Automobile Damages
- 5. Crosswalk Pedestrian Safety prior death in late 1980s

# Fixing this multi-layered problem requires a multi-level set of solutions:


- 1 & 2. Between 2045-2101 Huntington Drive, install a row of bollards at the curb to protect sidewalk pedestrians, waiting bus riders, and the homes that are in harm's way from cars.
- 3 a. Sync Huntington traffic lights Garfield Avenue to Alhambra Road to the posted speed limit of 40MPH (and add signage) to control speed of traffic through our high density residential street.
- 3 b. Nightly from 8pm-4am, turn every traffic light on Huntington blinking red. Saves energy, too.
- 4. On Huntington Drive, from the liquor store Pine Street to Olive Street add audible reflective asphalt markers or paint a reflective line (2' from the parked cars) to call attention to the cars.
- 5. We need a traffic light or at the least a pedestrian light requiring a mandatory stop at Huntington Drive and Court Street when red. This is where a child was killed in the late 1980s to early 1990s.

# What are Your Next Steps?

As Mayor Primuth wrote in a group email to me, SPPD Chief Brian Solinsky, Councilperson Janet Braun, City Manager Armine Chaparyan, and Bill Glazier from the South Pasadenan newspaper:

\* "Our public works and police department and commissions need to come up with safety improvements to protect our residents from this dangerous activity."

You are my second commission meeting and I need to know tonight, what are you going to do about it and when are you going to do it?

Hello,

Thanks for coming to meet with residents on Thursday. I live at block north of Huntington. Here are some of my concerns and safety choices.

- 1. I never use the crosswalk to cross Huntington at Court Ave, even though it's steps from my home. I always walk down to a light.
- 2. Headed east on Oak in a car, I'll never turn left to go north on Garfield in the morning because I'm afraid I'll get hit by oncoming traffic.
- 3. Headed south on Court in a car, I won't turn left to head east on Huntington.
- 4. People drive far too quickly through Court Ave and Camden Parkway. There are ~10 or more families here with small children who often play together in each other's yards and in the large median in Camden Parkway. I am constantly concerned that one of them will get hit, or that my son, when he is old enough to cross the road on his own, will get hit. All of the moms in our group have commented that they end up yelling at motorists a lot to slow down. Several of us have signs in front of our houses asking drivers to slow down.
- 5. I don't even feel safe walking on sidewalks on Huntington. When my family walks to the Lost Parrot, we walk north to Oak and then South on Fletcher to avoid walking on Huntington and also to cross at a light. We go on 2.5-3 miles walks every morning. We basically never cross Huntington on foot for these walks, always choosing one of several northern routes to avoid it.
- 6. We will not cross Garfield at Oak on foot even with the flashing pedestrian signs. I've seen too many close calls between motorists and pedestrians there.

Lastly, the road condition on Court Ave and Camden Parkway is really terrible. We have a neighbor who's lived here basically all of his ~50 year life and he said it's never been repaved in that time. There are sections that are approaching gravel road conditions. The older kids on our block who can ride their bikes in the street are often falling and getting hurt because of the road condition. Perhaps you can walk it some time to take a look.

My neighbor emailed an update on the community concerns for Huntington Drive, Camden Avenue, Court, etc. I live on Camden Avenue and frequently "try" to cross in the crosswalk at Court & Huntington. This morning I had safely crossed 1/2 way (south) and was waiting in the median for the cars going east bound to stop. The car in the lane closest to the median stopped for me, and was nearly rear ended. The traffic in the other 2 lanes just continued to breeze by, even though my bike and I had entered the lane that the stopped traffic was in. It was not until after several cars and a Metro bus had passed by the crosswalk that cars in the other 2 lanes finally realized there was a pedestrian and stopped. I walk and ride my bike all over town and have found that many drivers simply do not honor crosswalks, red lights and I cannot even count the number of times I have nearly been hit on my bike by people making illegal U turns, on Fair Oaks, as well as other streets. I don't know how you correct drivers poor behavior, but hopefully the city will find a way.

# TUESDAY, APRIL 18, 2023 MINUTES OF THE CITY OF SOUTH PASADENA MOBILITY AND TRANSPORTATION INFRASTRUCTURE COMMISSION REGULAR MEETING

#### CALL TO ORDER

Chair Dunlap called the Regular Meeting of the Mobility and Transportation Infrastructure Commission (MTIC) to order on April 18, 2023, at 6:34 p.m. The meeting was held in-person and virtually via Zoom.

### 2. Project Status Update

PWD provided an update on various projects. On Thursday, May 18, at the Library Community room at 6:00p.m., the City will be hosting an outreach event for the North South Corridor ITS project. The Slow Streets Program is moving forward and on schedule for review by the Commission next month. PWD Gerber stated a traffic impact analysis has been initiated for the 625 Fair Oaks project Senior Medical Housing Facility, which is being paid by the developer.

Public Works and the Police Department held a community meeting last Thursday night with the 2000 block of Huntington Drive to listen to their concerns and ideas for the City as a whole.

It was shared that a special "State of the Streets" meeting is planned for April 26, 2023, that will include the City Council and the Mobility & Transportation Infrastructure Commission to discuss street repairs, transportation projects, funding and such. The meeting will be open to the public.

The Measure R project focusing on the proposed improvements to Pasadena Avenue, on the border of Pasadena and South Pasadena approved first by the City of Pasadena, where they agreed to assist with funding has now been rejected. This will mean that South Pasadena would need to cover all related project costs. This can impact the current visibility of the project.

It was reported that there had been the initiation of improvements on Diamond Ave. The street will be monitored to see performance and we will look for community feedback.

ADA ramp projects will need to go out to bid. The bid process is being reviewed.

It was also reported that Alta is looking at the possible issue of closing off the Farmers Market area. There are some issues, as there are Gas Company related work that is planned for the area, which would limit projects.

It was shared that in regards to the Metro L (Gold Line) queuing, right now the timing is based on efficiency when there are two trains that cross the station. There could still be improvements.

Discussion ensued regarding various projects.

Commission Abelson asked about if the warrant analysis for the proposed signal was still scheduled to move forward, and asked that it be included on the projects list. He also asked for more information regarding the issues Columbia Street. In addition, he asked about if the draft Ramona Avenue, school plan had been shared with the South Pasadena Unified School District. He also referred that the Commission or public had not seen the recent completed Traffic Study.

Commissioner Fisher asked about the Mission Street and Meridian Ave. signal timing, as he said that there is area for improvement, especially with pedestrian interval improvements. He also wanted to make sure that if a lane is removed from Mission St. as part of the pilot, there will need to be mitigation actions.

Chair Dunlap asked what might be the hinderance to implemented timing improvements, such as lack of in-house staff for getting assistance with signals.

### **ACTION/DISCUSSION ITEMS**

### 3. Evaluation of a Second Crossing Guard on Huntington Drive and Marengo Avenue

TPM Pena gave a brief overview of this item. Staff is requesting that the Commission consider the draft report provided by Minagar & Associates, Inc. and provide input and recommendations related to the draft findings, and further recommendation to Council on next steps.

Public Comment Via Zoom

Alexis Altounian – Expressed support for the second crossing guard. It was shared that in 2003, a crossing guard for the area was struck by a vehicle.

Ella Hushagen – Expressed support for the second crossing guard. She also suggested that perhaps a "Scramble Crossing" could improve safety.

Eva Romero – Expressed support for the second crossing guard. She shared how she was almost hit at the crosswalk.

**End of Public Comment** 

Discussion ensued.

A motion was made to recommend that the consultant revise the report to reflect quantifiable data to justify the recommendations; 2) that the consultant consider recommendations from the CA MUTCD with regard to countdown signals, accessible pedestrian signals, and retiming of the signal to reflect modern practices with regard to pedestrian timing yellow and all red timing; and 3) the consultant consider protected left turn for either Northbound or Southbound movement if it can be shown that their paths interlock with each other.

There was significant discussion regarding the report and the issue, including that more information would be helpful such as crash data beyond five years. It was also discussed how some the report recommendations would require large capital expenditures, such as raised crosswalks. Signal timing can also be reviewed for added safety. It was also noted that no speed data was shared. It was also noted that no information from the actual crossing guards was included in the report.

Motion made by Commissioner Dunlap and seconded by Commissioners Hughes to continue staffing the intersection with a second adult crossing guard for the 2023-2024 school year if funding allows (2-2, motion fails)

An amendment by Commissioner Abelson was presented - the consultant, as part of this revision process come back with more of a narrower list/smaller set of data supported recommendations (Fisher, Abelson 4-0)

## 4. Approval of Minutes of the Regular Mobility and Transportation Infrastructure Commission Meeting on March 21, 2023

Minutes approved as amended. Motion made by Commissioner Hughes and seconded by Commissioner Abelson (4-0, motion passes).

Council Liaison Donovan reminded the Commission of the Special Joint meeting on Wednesday, April 26.

#### 6. Commissioner Communications

Commissioner Hughes announced that the Eastern Sierra reached its highest level of snowpack in recorded history over 300 percent. She is enjoying the look of the South Pasadena Rock sign and hopes the community is enjoying the signage as well.

Commissioner Abelson informed the Commission of the invitation to participate in a budget survey and if not, the survey is accessible on the City website. The deadline to submit the survey is April 21. He cautioned everyone to drive safely after an incident with South Pasadena Police Officer Holland, who is now recovering. Commissioner Abelson reminded everyone regarding the concerns of residents of Orange Grove between El Centro and Monterey Road with speeding on their street.

Commissioner Zavala announced that he received his driver's license and how that has given him a wider perspective not just as a biker or a pedestrian and gives him an understanding of the habits of drivers, however he will continue to ride his bike.

Commissioner Fisher thank staff for being responsive. He also welcome David Pena to the Public Works Department. He commented how on Orange Grove between Monterey Road and El Centro an easy solution would be to shift parking to one side of the street and allow two lanes of traffic to travel without conflict.

Commissioner Dunlap reminded the Commission of the Work Plan that would be on the next agenda and start thinking of items we want to consider for the coming year.

### 7. Staff Communications

PWD Gerber next week will be a Special Joint Meeting with City Council and MTIC in the Council Chambers at 6:30p.m. on April 26, 2023. The Commission Congress is coming up and the commission will need to prepare two slides for presentation at the meeting, as part of the Annual Report reporting.
