COMMITTEE CHAIR REPORTS

4. DESIGN AND SITE CHAIR REPORT

Jontz reported going forward, any design adjustments going forward will need to be brought to a design meeting at the Tournament House which takes place on the first Tuesday of each month through November. Jontz reported the tent, side tent and porta-potty have all been delivered. The overhead wiring for lighting has been installed and looks much cleaner than years past, appreciation was given to all those who helped get the tent up and organize. Concern for expenses was discussed- construction team purchased an extra spider box which was done without approval. As the Site Chair, all expenses should be communicated and approved by Jontz. Dunlap confirmed with Jontz the tent contract is under existing that we signed for a total of three consecutive years. Fielding commented that the souvenir booth only has partial power as well as low Wi-Fi strength, Jontz confirmed he would address it.

5. CONSTRUCTION CHAIR

Carlson reported the tent went up on July 30th; appreciation was given to all who helped. Starting next week, construction will have three workdays to include Tuesdays, Thursdays and Saturdays. Technical issues from the 4th of July parade have been addressed and corrected. Mechanical 1 inspection is scheduled for 7am on August 15th.

6. DECORATION CHAIR

Glauz reported inventory will be taking place on Saturday July 11th so material orders can be finalized.

7. SOUVENIR CHAIR

Fielding reported the souvenir booth will be open on Saturdays. The South Pasadena design pins should arrive in about two weeks.

8. DIRECT MARKETING CHAIR

No report- absent.

9. VOLUNTEER CHAIR

No report- absent.

10. WEBSITE CHAIR

Strong reported all events have been updated on the website.

11. CRUNCH TIME CHAIR

No report- absent.

12. YARD SALE

Steve Fillingham reported he has gotten a few emails for large item pick up. We did not store any remaining items from last year, so we are starting this sale from scratch. Volunteers are needed for large item pick up, receiving items, organizing and pricing items, day of help and event clean up. Fillingham asked for each Committee member to come and help for 1 hour, it will make a world of difference. J. Benjamin commented she shared the sign-up genius link in her weekly email and asked for it to be shared by the Committee.

13. TENT BANNER REPORT

Dunlap reported this year we have sold about 30 banners, 7 new businesses including Sharp Seating and Villa's Tacos. Sharp Seating will be coming by the tent to show some of our progress on their socials. We should make about \$3,000 more than last year. Dunlap is working on sponsorship recognition via socials and on our website with Alex, Karie and Chris. Most if not all banners will be in the next 2-3 weeks.

14. MISCELLANEOUS FUNDRAISER REPORT

Fielding reported she has reached out to See's Candy for our fall fundraiser. Parker reported that the revenue from the Pasadena Showcase house funds is listed under miscellaneous fundraising on financials.

16. PUBLICITY CHAIR REPORT

Reynolds reported she has been promoting the yard sale to lots of outlets; some have also re-shared it with their own followers. Reynolds mentioned John Vandercook, a past long time SPTOR board member/supporter who is being honored this month as a Senior Champion and asked the Committee to consider attending the event on August 10th.

18. GOLF TOURNAMENT REPORT:

Community Services Director Snyder commented the golf course has a new contract agreement for remodel. The plans have not been released yet, but possible plans include a course closer from Spring-Summer. She will update the Committee when plans have been approved.

Sam Hernandez reported there is an upcoming meeting with the Fire Chief and City Manager and the Planning Commission to go over building requirements. In the last Closed Session, City Council approved our building, the next steps are to come to an agreement of terms and see what that looks like for SPTOR. Tentative building will be a 3-year process-1 year for building which means we will need to find a temporary location for 1 year.
