HEARING ITEM(S): PUBLIC HEARING AND ADOPTION OF AN ORDINANCE AMENDING

ARTICLE 1 OF CHAPTER 9 OF THE SOUTH PASADENA MUNICIPAL CODE BY MODIFYING CERTAIN PROVISIONS THEREIN AND ADOPTING BY REFERENCE THE 2025 CALIFORNIA BUILDING, RESIDENTIAL, ELECTRICAL, MECHANICAL, PLUMBING, GREEN BUILDING STANDARDS, HISTORICAL BUILDING, EXISTING BUILDING AND REFERENCED STANDARDS CODES; AND THE 2025 CALIFORNIA ADMINISTRATIVE CODE, CHAPTER 96 OF TITLE 26 OF THE LOS ANGELES COUNTY CODE AND INCLUDING CERTAIN

AMENDMENTS, ADDITIONS AND DELETIONS THERETO

1. Hold a Public Hearing to hear any objections of an ordinance adopting by reference 2025 California building, Residential, Electrical, Plumbing, Mechanical, Green Building, Historic Building and Administrative Codes; and

2. Adopt Ordinance No. 2407 (Attachment "1"), "An Ordinance of the City of South Pasadena, California, amending Article 1 of Chapter 9 of the South Pasadena Municipal Code by modifying certain provisions therein and adopting by reference the 2025 California Building Code; the 2025 California Residential Code; the 2025 California Electrical Code; the 2025 California Mechanical Code; the 2025 California plumbing code; the 2025 California Energy Code; the 2025 California Green Building Standards Code; the 2025 California Historical Building Code; the 2025 California Existing Building Code; and the 2025 California referenced standards code; the 2025 California Administrative Code; Chapter 96 of Title 26 of the Los Angeles County Code and including certain amendments, additions and deletions thereto."

The California Building Standards Codes have been adopted and published by the California Building Standards Commission and will take effect January 1, 2026 and apply statewide. Cities may make modifications to the Building Standards Code and provide for local amendments if the amendments are necessary because of local climatic, geological or topographical conditions. Ordinance No. 2407 adopts the Building Standards Code and includes the following revisions:

- 1. Article I of Chapter 9, related to unreinforced masonry and seismic safety, are being retained and realigned under Article III to maintain continuity with the prior Building Code.
- 2. Article I of Chapter 9 on certain administrative items amended based on administrative needs identified in prior years, this would consolidate local provisions for permit expirations, extensions, refunds, valuation, and certificates.
- 3. Adoption of 2025 Building, Residential, Electrical, Mechanical and Plumbing Codes with minor amendments to the California Code.

- 4. Building Code Chapter 9, Chapter 15 and Residential Code Sections R309 and R902.2.1 are amended to align with the existing Fire Code amendments to keep the codes correlated with each other.
- 5. Building Code Chapter 33 and Residential Code R301.1.3.2 are amended to carry out existing amendments to this new code cycle.
- 6. The remaining titles of the Building Standards Code (Administrative Code, Energy Code, Historical Building Code, Existing Building Code, Referenced Standards Code) are being adopted as is.

On November 5, 2025, the City Council introduced the ordinance and set a public hearing as required by Government Code Section 50022.3. The purpose of this meeting is to hold the public hearing and adopt Ordinance No 2407. Adoption will maintain compliance with State standards for the design, construction, and maintenance of physical buildings to ensure the safety, health, and welfare of the public. In addition, as required by Government Code Section 50022,6 a copy of the 2025 edition of the California Building Code, Residential Code, Electrical Code, Mechanical Code, Plumbing Code, Energy Code, Green Building Standards Code, Historical Building Code, Existing Building Code, the Referenced Standards Code, and the Administrative Code are on file with the City Clerk and available for public inspection during normal business hours.
