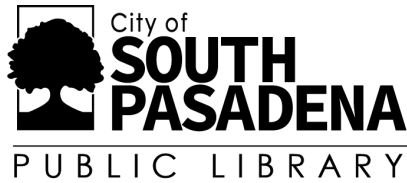

## **GET A SOUTH PASADENA PUBLIC LIBRARY CARD**

**Please read the following and complete the form on the reverse.**

A library card or a digital wallet library card must be presented each time materials are borrowed. A library card is needed to use library computers and most of the library's online resources, including eBooks and eAudiobooks, streaming films, magazine and newspaper articles, and many others.

### **LIBRARY CARD APPLICATION**

Please read carefully and print legibly.

All residents of the State of California are eligible to get a library card.

Adult applicants must present photo identification and proof of mailing address with this application. Identification may be any of the following:

- Photo ID: may include California driver's license or California ID, student or work photo ID, passport, or any other state or federal issued photo ID.
- Proof of mailing address: If not on the photo ID, may include a piece of mail received at the customer's current address, a utility bill, rental agreement, personalized check, or car registration.

### **CARDS FOR CHILDREN AND TEENS**

A parent or legal guardian must be present to sign their child or teen's library card application in order for it to be valid, and must present ID as described above.

Parents are responsible for the materials borrowed on cards belonging to their children who are under the age of 18.

Note: Children under 11 must be accompanied by an adult at all times in the Library.

**Protecting customer privacy is important to us. The information collected on the library card application is not shared with outside parties. The library will only release information to a customer regarding their account if a valid library card or photo ID is presented.**
