ACTION/DISCUSSION

2. RECEIVE AND DISCUSS THE RACIAL AND IDENTITY PROFILING ACT OF 2015, ASSEMBLY BILL 953, AND ARREST DATA AS IT PERTAINS TO THE SOUTH PASADENA POLICE DEPARTMENT

Recommendation

It is recommended that the City Council receive and discuss the Racial and Identity Profiling Act (RIPA) of 2015, Assembly Bil 953 (AB 953), and arrest data as it pertains to the South Pasadena Police Department.

Police Chief Brian Solinsky and Bob Scales from Police Strategies, LLC presented item no. 2.

Councilmember Cacciotti asked if this report takes into consideration demographic regions.

Mr. Scales responded that the population benchmark is used to produce this report. Councilmember Braun asked if this data is from 2022 or 2023. Police Chief Solinsky clarified that data started being collected in 2022 but the dashboard reflects the most recent data. Mayor Zneimer pointed out that data in packet received by Councilmembers and Commissioners is not accurate with what is on the presentation.

Mayor Zneimer asked if this report is ADA Compliant. Mr. Scale responded that it is not ADA compliant, however, if the City Council prefers it, they can make it ADA complaint.

Mayor Zneimer asked why there was a peak in April 2023 on traffic stops. Police Chief Solinsky responded that he would have to go back and inspect the records.

Public Safety Chair Cervantes commented that is an alarming picture of South Pasadena to have the second highest rate after Los Angeles and mentioned that this is unfair to the city. Police Chief Solinsky responded that they could collect more data sets. Mr. Scales remarked that only fifteen percent of arrestees are South Pasadena residents.

Commissioner Gee asked what the cost is of the dashboard and if it was budgeted. Police Chief Solinsky responded that it costs \$10,000 and the dashboard was budgeted for the upcoming fiscal year.
