NOTICE IS HEREBY GIVEN that the City of South Pasadena Cultural Heritage Commission will hold a public hearing on January 15, 2026, at 6:30 p.m. through an in-person meeting to consider the following projects:

PROJECT NO. COA24-0013 – A request to permit a Certificate of Appropriateness (COA) to demolish an existing attached carport for a new 876 square-foot rear single-story addition with an 808 square-foot garage beneath the proposed addition. The proposed garage will include a 382 square-foot utility room and a 302 square-foot attached carport to an existing 3,464 square-foot single-family dwelling located at 2021 Milan Avenue (APN: 5320-016-005). In accordance with the California Environmental Quality Act (CEQA), a Categorical Exemption under Section 15301, Class 1 (Existing Facilities) and Section 15331, Class 31 (Historical Resource Restoration/Rehabilitation) will be considered for the project.


