ORGANICS RECYCLING MANDATE FOR MULTIFAMILY COMPLEXES

Dear Multifamily Owner and/or Manager,

In 2016, the State of California passed Senate Bill (SB) 1383, California's Short-Lived Climate Pollutant Reduction Strategy. As of January 1, 2022, all businesses (including multifamily complexes) are required to subscribe to an organics collection service and must separate into an organics container ALL of their landscaping waste, food scraps, and food-soiled paper (100% fiber-based). Businesses must also subscribe to a recycling collection service and place recyclable materials, such as aluminum cans and foil; aseptic and gable top cartons; cardboard; glass bottles and jars; mixed paper; and plastics #1 (bottles and clamshells), #2, and #5.


WHY ORGANICS COLLECTION?

SB 1383 targets the statewide reduction of methane emissions from landfills, the 3rd largest source of methane in California. Decomposing organics in landfills emit 20% of the state's methane; a climate super pollutant up to 84 times more potent than carbon dioxide. By diverting organics from the landfill, you are part of the solution in helping to protect the environment and future generations.


WHAT IS REQUIRED?

Multifamily complex property owners and/or managers must:

- Subscribe to a collection service for ALL organics waste that is adequate in size and frequency.
- Subscribe to a collection service for ALL recyclables that is adequate in size and frequency.
- Provide organics waste and recycling collection options for both employees and tenants that is easily accessible and includes correct labels and signage.



Educate new tenants on your organics waste program within 14 days of move-in.

MULTIFAMILY ORGANICS WASTE & RECYCLING PROGRAM CHECKLIST

To ensure a successful Food Scraps & Recycling Program at your property, follow this friendly step-by-step checklist.

1. Immediate Steps

- ☐ Review *this manual*.
- ☐ Connect with an Athens representative to identify your adequate organics waste and recycling service levels and bin/cart placement.
- ☐ Choose your organics waste collection start date.
- ☐ Choose your recycling collection start date.
- □ Update your tenant onboarding document using the *Recommended Language for Tenant Move-In Packet*.

2. Program Set Up

- □ Decide how tenants will be disposing of their organics waste and recyclables:
 - ☐ Place organics and recyclables directly into the green and blue Athens containers, respectively
 - ☐ Internal drop-off locations throughout property
 - □ Dedicated organics waste or recycling chute
 - □ Valet services
- □ Decide if management will provide a kitchen pail, compostable bags, and a bag dispenser for the collection of organics waste. If interested, Athens can provide a list of resources.
- ☐ If management is providing kitchen pails or working with a valet service company, Athens can provide kitchen pail stickers and the *Residential Food Scrap Collection* flyer.
- □ Review program requirements with all employees, including management, administration, maintenance/custodial staff, and any third-party custodial services.
- ☐ Schedule employee training with your Athens representative to go over recommendations and best practices.
- □ Internal containers serviced by the property (including recycling and trash, and organics where applicable), must be grouped together, easily accessible and visible, clearly marked with signage on what "can or cannot be placed into each container," and properly serviced for recycling and composting.

3. Tenant Training

- Utilize the email templates in this manual to communicate to your tenants. (Only send emails to tenants of properties receiving organics waste and recycling services provided by Athens. Do not send to your full property portfolio.)
- ☐ Send tenants the *Resident Introduction Email (template provided.)*
- ☐ If management is providing kitchen pails, have kitchen pails ready for distribution and mark the bottom with the unit number to relocate misplaced containers.
- ☐ Following rollout, send tenants Resident Follow Up Email (template provided) within 48 hours.

4. Ongoing Check Ups

- ☐ Per Senate Bill 1383, annually educate employees, contractors, and tenants on how to properly sort waste into the correct bins.
- ☐ Per Senate Bill 1383, provide information to new tenants within 14 days of occupation of the premises.
- ☐ Have employees and maintenance/custodial staff monitor organics and recycling containers for contamination.
- □ If the organics container is in need of a cleaning, call the Athens Customer Care Center at (888) 336-6100.
- ☐ Consider emailing tenants a *Tenant Participation Survey* to gather feedback and improve upon your program (*template provided*.)





RESIDENTIAL FOOD SCRAP COLLECTION

Athens Services is partnering with your city to implement food scrap collection for single-family home residents and multifamily complexes. Per Senate Bill 1383, single-family home residents and multifamily complexes across California are required to place into their green waste container ALL of their landscaping waste, food scraps, and food-soiled paper (100% fiber-based).

WHAT'S CHANGING? You are able to use your green organics container for the collection of landscaping waste, food scraps, and 100% fiber-based, food-soiled paper.

DID YOU SAY FOOD SCRAPS? Yes, Athens accepts all types of food scraps. Our American Organics compost facility converts organics waste into nutrient-rich soil amendment. The resulting compost is used by commercial farmers, city projects, garden shops, landscapers, and residents.

HOW DO I PARTICIPATE? To collect your kitchen food scraps, you can choose to use a portable, reusable pail-like container with a tight fitting lid. It could be plastic, metal, or ceramic. Pail options can be purchased or consider reusing a coffee canister, large yogurt or margarine tub, or juice pitcher. Storage ideas can include the kitchen counter, under the sink, in the freezer, or wherever you feel is best.

WHY ORGANICS RECYCLING? Landfills are the third largest source of methane in California. Organics waste emits 20% of the state's methane. By diverting organics from the landfill, you are part of the solution in helping to protect the environment and future generations.

ARE BAGS ACCEPTED? Liners are optional. Consider newspaper or a paper bag. Plastic and bioplastic "compostable" bags are accepted in the organics container, but must be CLEAR or translucent-green, and bag contents must be visible. Acceptable organics will be processed, but the bags will not be recycled or composted.

PARTICIPATING IS EASY AS 1-2-3



1. FILL

Fill your pail with food scraps and acceptable items. (Liners are optional. Consider newspaper or a paper bag. Plastic bags must be clear.)

2. EMPTY

Empty pail contents into your green organics container.





3. RINSE & REPEAT

Rinse out pail with soap and water. Fill again. Sprinkle lightly with baking soda to absorb odors.

Athens Tip: Store meat and dairy scraps in a container in your freezer and place in the green organics container on collection day.

ORGANICS WASTE & RECYCLING MANUAL RESIDENT INTRODUCTION - EMAIL TEMPLATE

Purpose: It is essential that your multifamily tenants are aware of your new food scraps collection and recycling program. To ensure successful participation and limit contamination, Athens recommends **sending your tenants an introduction email one week before the program starts** to notify them of the new program. If you have any questions, please reach out to your designated Athens representative.

INSTRUCTIONS

- 1. Copy and paste the below text into an email and send it to your tenants.

Through composting and mulching, Athens helps reduce greenhouse gas (GHG) emissions by limiting the amount of methane generated from the decomposition of organics in a landfill. Recyclable materials are sorted by material type at a Materials Recovery Facility and shipped to processors for remanufacturing.

ORGANICS WASTE & RECYCLING MANUAL WHERE DOES IT GO? HAZARDOUS & ELECTRONIC WASTE

It is illegal to place hazardous or electronic waste in the trash, recycling, or organics container. The State of California provides a list of banned materials from the landfill that require special drop off.



Household Hazardous Waste (HHW)

Hazardous waste includes anything labeled toxic, poisonous, corrosive, flammable, combustible, or irritant. It is illegal to dispose of these items in your waste containers, sinks, or storm drains. Contact with these materials can be extremely dangerous for waste workers, the community, and the environment.

Examples include, but are not limited to, antifreeze, automotive fluids, cleaning products, compressed gas cylinders (full or empty), fertilizers, herbicides, paint, pesticides, pharmaceutical medicine, sharps, and solvents.

Universal waste is a subcategory of hazardous waste. Examples include, but are not limited to batteries; light bulb lamps (LED, compact fluorescent bulbs, and tubes); mercury-containing items; non-empty aerosol cans; photovoltaic modules (solar panels); and printer ink cartridges.



Sharps/Medication

As part of Senate Bill 212, residents (at no additional cost) can safely and conveniently dispose of their pharmaceutical and home-generated sharps waste through authorized collection sites or mail-back services. For more information, visit Med-Project.org or SafeMedicineDrop.com.



Electronic Waste (E-Waste)

E-waste is anything that plugs into an electrical outlet, uses bulbs or batteries, and/or contains an electronic circuit board or wiring. Examples include, but are not limited to, computers and accessories, circuit boards, extension cords, flashlights, microwaves, phones, stereos, and televisions.

ORGANICS WASTE & RECYCLING MANUAL WHERE DOES IT GO? BULKY ITEM COLLECTION

Oversized items (aka bulky items) are not allowed in the trash, recycling, or organics container. **Common items include furniture, large electronics and appliances, barbecue grills, mattresses, and toilets.**

What Is Considered Bulky?

- Items that are too large to fit in the trash container, such as air conditioners, appliances, furniture, and TVs.
- •Items that cannot be handled by two workers will NOT be accepted, such as a piano or a pool table.
- Note: Athens does NOT collect car parts, glass, mirrors, or hazardous waste as part of bulky item pickup.

Consider Repair or Donation

Most bulky items are sent to landfill and not recycled. Unwanted items might be given a second life if repaired or donated. Click here for ideas.

Schedule A Bulky Item Collection

Bulky item collection options may vary depending on the rules of your apartment complex. Check with your property management on how tenants should dispose of their bulky items. Some properties may have a dedicated pickup day or on-site collection area. Other properties may ask tenants to contact the city or Athens Services directly for disposal options.

Bulky items collections vary per city. Check your Athens' <u>city page</u> to confirm the process, acceptable items, collection instructions, applicable fees, and quantity of available collections per account. For more information, call Athens' Customer Service Department at 888-336-6100.



Prepare For Bulky Item Pickup

- Check with your property management for any specific disposal procedures.
- Protect children by removing or securing appliance doors.
- Place items at curbside and do not leave them in the street or block driveways.

Convenient Curbside Collection - Now 4 Times a Year!

NEW BULKY ITEM PROGRAM STARTING JULY 21, 2025

Athens, in partnership with the City of South Pasadena, is launching a new bulky item pickup program. Residents can now request curbside collection of bulky items through Athens, up to four times per year, at no additional charge.

- Single-family residents: One bulky item pickup per quarter (up to four times per calendar year; maximum of five items per pickup)
- Multifamily units: One bulky item pickup per quarter, (up to four times per calendar year; maximum of five items per pickup). Tenants must coordinate with their property owner or HOA to schedule service.

Including but not limited to:



Furniture

Chairs, sofas, mattresses, rugs



Appliances

Refrigerators, washers, dryers, water heaters, plumbing, small household appliances



Green waste

Yard trimmings, bundled wood (max, 1 cubic yard)



Clothing

IMPORTANT REMINDER

Dumping items on the sidewalk without scheduling a pickup is illegal per City Ordinance 1216.2.

NOT ACCEPTED

These items will not be collected:



Car bodies



Tires



Construction debris



Electronic waste

Computers, televisions, etc.



Hazardous materials

fluorescent bulbs, batteries, etc.

Scan to schedule a pickup

Place items at your curb by 6 a.m. on scheduled pickup day

Other items not specifically included or excluded above will be collected provided that they are no more than eight (8) feet in length, four (4) feet in width, or more than one hundred and fifty (150) pounds.
