### GENERAL REBATE REQUIREMENTS AND CONDITIONS

*\*Please read all requirements carefully before purchasing devices and submitting applications\**

1. Must completely fill out, sign, and date rebate application.
2. Name on application **must** match name on water account. If part of HOA, must provide proof of residence via copy of water bill or verification letter from HOA.
3. Must include copy of itemized receipt showing date and purchase of device (invoices are not accepted – must show that a payment was made).
4. Applications must be submitted within 90 days of the purchase of a qualifying device.
5. Water account must be in good standing (account with a zero balance).
6. Rebate amount is limited to the cost of the device(s). The actual device costs exclude tax, shipping, labor and other charges.
7. Rebate applications will be processed within 4-6 weeks.
8. Rebates are available on a first-come, first-served basis and are subject to the availability of funds.
9. Rebate amount and requirements are subject to change or terminate without prior notice.

### WATER EFFICIENT DISHWASHER – Up to \$500 per household

- Dishwasher must be selected from pre-approved list of Water Efficient Dishwashers

To Apply:

1. Purchase dishwasher from pre-approved list of dishwashers.
2. Submit rebate application including a minimum of two (2) “before” photos of your old dishwasher, copy of receipt, and a minimum of two (2) “after” photos of your newly installed water efficient dishwasher.

### DRIP IRRIGATION CONVERSION – Up to \$300 per household

- Must replace non-drip irrigation system [i.e. sprinklers, flood irrigation, soaker hoses]
- Receipts for the following drip irrigation materials can be submitted for the rebate: valves, backflow preventers, pressure regulators, filters, tubing adapters, drip tubing, emitters, and end caps
  - INELIGIBLE PRODUCTS: bubblers, microspray, drippers, point source emitters]
- *Please note: Proposals, estimates and bills are not eligible receipts/invoices. Submitted receipts/invoices must document payment completed.*

To Apply:

1. Purchase parts and install drip irrigation to replace non-drip system.
2. Submit “before” photos (minimum 2 photos) of pre-drip irrigation system. Photos must:
  - Be in color
  - Include minimum one photo that shows property
  - Include minimum one photo that clearly shows non-drip irrigation system & area(s) of landscape to be irrigated with drip
3. Submit completed rebate application, copy of receipt(s), and a minimum of three (2) “after” photos.

### TREES - Up to \$100 per tree (maximum 10 trees per household)

### WATER EFFICIENT PLANTS – Up to \$1,200 per household

- Trees must be selected from pre-approved list of South Pasadena Protected Native Trees
- Plants must be selected from pre-approved list of South Pasadena Water Efficient Plants
- Plants must replace nonnative or water intensive plants

To Apply:

1. Use pre-approved lists to purchase and plant trees and plants.
  2. Submit “before” photos (minimum 3 photos) taken before planting. Photos must:
    - Be in color
    - Include minimum one photo that shows property
    - Include minimum two photos that clearly show area where native trees/water efficient plants will be planted
  3. Submit completed rebate application, copy of receipt(s), and a minimum of three (3) “after” photos.
