**MINUTES OF THE REGULAR MEETING OF THE  
FREEWAY AND TRANSPORTATION COMMISSION  
OF THE CITY OF SOUTH PASADENA  
CONVENED THIS 20<sup>th</sup> DAY OF JUNE 2017 6:37 P.M.

<b>1. ROLL CALL</b>	The regular meeting of the Freeway and Transportation Commission (FTC) was convened at 6:37 P.M. Commissioners present: Kuhn, Sherman, Nuckols, and Helgeson; Commissioner absent: Reynolds; Council Liaison: Khubesrian absent; Councilmember Schneider; and Staff present: Principal Management Analyst (PMA) Lin.
<b>2. PUBLIC COMMENTS</b>	None.
<b>3. APPROVAL OF THE MINUTES</b>	The May 16, 2016 regular meeting minutes were approved (3 ayes, 0 noes, 2 absent)
<b>4. COMMISSIONER COMMENTS</b>	None.
<b>5. COUNCIL LIAISON COMMENTS</b>	None.
<b>6. STAFF COMMENTS</b>	None.
<b>7. PUBLIC COMMENTS (ITEMS NOT ON THE AGENDA)</b>	Residents from Fremont Avenue expressed concerns regarding the constant traffic congestion on Fremont Avenue and the associated difficulties of getting out of their driveways. The residents also provided comments regarding their concerns with some of the projects identified in the Transportation System Management/Transportation Demand Management project list.
<b>8. DISCUSSION ITEMS</b>	
<b>A. SR-710 Updates</b> <b>1. TSM/TDM Project List</b>	Vice-chair Nuckols stated that the Fremont Traffic Calming Plan identified Fremont Avenue as a residential street and included projects that would slow down traffic; suggested that a transportation consulting firm should be hired to evaluate and update the Traffic Calming Plan, and stated that Metro staff would be reaching out to the cities listed in the May 25 <sup>th</sup> Metro Board motion to discuss the project for the remaining Measure R funds. Commissioner Sherman stated that the update of the Fremont Traffic Calming Plan should include a public meeting; and that the SR-110 Hookramp Project, Fremont Traffic Calming, and Fair Oaks Improvements should be included in the City's list of projects for the remaining Measure R funds. The FTC also discussed the truck restrictions north of Huntington Drive, possible signal synchronization on Fremont Avenue, and traffic congestion associated with the Metro Gold Line crossings. The FTC made a motion to recommend to the City Council to hire a transportation consultant to evaluate the TSM/TDM project list, Fair Oaks Avenue Improvement Plan, Fremont Traffic Calming Plan, Beyond the 710, and the Metro

	Gold Line crossings to identify projects within the City that would best utilize the remaining Measure R funds. A second motion was made to recommend to the City Council to reconsider overnight parking at the Mission Meridian Parking Garage to allow the Community Development Commission of the County of Los Angeles to provide shuttle services for their employees from the South Pasadena Gold Line station.
<b>B. Joint FTC and Public Works Commission (PWC) Report</b>	PMA Lin reported that the City Council would review the joint report during their July 18, 2017, meeting.
<b>C. SR-110 Updates</b>	PMA Lin reported that the City was still waiting for a response from Caltrans.
<b>9. AGENDA INPUT</b>	None.
<b>10. ADJOURNMENT</b>	By consensus, the Commission adjourned the meeting at 7:40 P.M.
