On page 7-3 of the January 17, 2018 City Council Meeting Agenda Packet, the November 15, 2017 City Council Meeting Minutes contain the following modifications requested by a member of the City Council. Please note additions are underlined and deletions are stricken through.

Councilmember Mahmud provided an update regarding the progress of the Los Angeles Community Choice Energy, noting that Phase I servicing the Los Angeles County (County) load will soon begin and is 60% renewable energy, double that of Southern California Edison (SCE); stated that the Library Board of Trustees will take final action regarding the formation of a Library Foundation; reported a recent invitation ~~to be a personal representative~~ to a Stakeholder Committee as a representative on behalf of Supervisor Kathryn Barger, ~~regarding environmental justice and the intent to reach an agreement on the main elements of a County Clean Water Initiative which is designed to capture storm water for reuse~~ regarding a proposed tax measure that would augment local water supplies and facilitate stormwater compliance; provided a summary of the recent trip to Sacramento, CA with Director of Public Works Director Toor to meet with the State Water Resources Control Board to discuss water quality ~~recommendations~~ regulations.



At least 623 children have been murdered in the United States by a parent involved in a divorce, separation, custody, visitation, or child support situation.

Researchers who interviewed judges and court administrators following some of these tragedies found that **most believed these were isolated incidents**. Needed reforms have not been implemented.

Many court-related child homicides occurred after family courts **granted dangerous parents access to children** over the objections of a protective parent.

Abusive parents are often granted custody or unprotected parenting time by family courts—placing our nation's children at ongoing risk.

#1 The safety and well-being of children should always be the first priority in child custody and visitation cases.
