Biographical Note

Dr. Richard "Rick" D. Schneider was first elected to the South Pasadena City Council in 2007. During the 2017-2018 term, he served as mayor. He is a part of several community groups, including South Pasadena Beautiful, the Friends of the South Pasadena Public Library, and the South Pasadena Preservation Foundation. He is also a longtime opponent of the controversial 710 Freeway extension connecting Valley Boulevard in Alhambra to the 210 Freeway in Pasadena as it would have cut through the city of South Pasadena.

An avid cycling enthusiast, he bikes daily to Hollywood Presbyterian Medical Center and St. Francis Medical Center, where he is a pathologist. He and his wife, Pauline, have four children and five grandchildren.
