Biographical Note

Glen Duncan serves as president of the California Historic Route 66 Association. The group worked with South Pasadena City Council to paint the Route 66 emblems on Fair Oaks Avenue. Mr. Duncan is involved in the Cultural Heritage Commission and the South Pasadena Preservation Foundation. His passion for preservation led him and his wife, Pat, to fight against the 710 Freeway extension, which would have destroyed South Pasadena historical homes.

Mr. Duncan was born in Baxter Springs, Kansas, and is the author of "Route 66 in California."
